PURCHASER AND BREEDER IS IN ACCORDANCE WITH THE TERMS OF THIS AGREEMENT AS PROVIDED ON THIS CONTRACT.

- 1. SELLER AGREES PUP/DOG WILL BE RECEIVED BY THE BUYER IN GOOD HEALTH HAVING RECEIVED ALL DE-WORMING'S AND SHOT'S REQUIRED FOR THE DOGS AGE. PUP/DOG WILL BE RECEIVED BY BUYER WITH A COMPLETE HEALTH RECORD, ALSO CKC REGISTRATION CERTIFICATE TO TRANSFER OWNERSHIP. IFCKC REGISTRATIION PAPERS HAVE NOT ARRIVED AT TIME PUP/DOG IS PICKED UP, ARRANGEMENTS WILL BE MADE FOR THEM TO BE MAILED CERTIFIED WITH DELIVERY CONFIRMATIONN TO THE BUYER AS SOON AS THEY ARE RECEIVED. IF YOUR PUP/DOG REQUIRES SHIPPING, REGISTRATION PAPERS WILL NOT BE SENT WITH PUP/DOG. THEY WILL BE SENT CERTIFIED MAIL WITH DELIVERY CONFIRMATION REQUIRED. SELLER DOES NOT GUARANTEE COLOR OR THE PUPS, TO BE SHOW QUALITY. SELLER ALSO MAKES NO GUARANTEE TO SIZE OR WEIGHT OF DOG AT MATURITY. A LOT OF THIS DEPENDS ON THE CARE THAT YOUR DOG RECEIVES WHICH IS BEYOND THE CONTROL OF THE BREEDER.
- 2. IF RECEIVING YOUR PUP/DOG REQUIRES SHIPPING, SHIPPING CHARGES(i.e. Airfare, Crate, HealthCertificate from the Vet)MUST ALSO BE PAID IN FULL BY THE TIME THE PUP REACHES 7 WEEKS OF AGE OR AGREED DUE DATE, AIRLINE SHIPPING INCLUDES: AIRFARE, QUALITY CRATE

WITH PADDING, FOOD & WATER DISH, AND HEALTH CERTIFICATE, DATE OF SHIPPING WILL BE AGREED UPON BY BOTH PARTIES AND SCHEDULED ACCORDING TO FLIGHT TIMES AGREED UPON BY BOTH PARTIES AND SCHEDULED ACCORDING TO FLIGHT TIMES OFFERED BY AIRLINE. ANIMALES WILL NOT BE SHIPPED UNTIL ALL MONEY IS RECEIVED. FAILURE TO PAY ALL MONIES OWED BY 7 WEEKS OF AGE OR DUE DATE WILL RESULT IN THE FORFEITING OF ALL MONEY PAID.

3. IF THE PUP DEVELOP A LIFE THREATENING ILLNESS PRIOR TO 1 YEAR OF AGE BREEDER SHOULD BE NOTIFIED IMMEDIATELY. CASES WHERE IT IS RECOMMENED PUP SHOULD BE EUTHANIZED DUE TO ILLNESS. BREEDER MUST BE PROVIDED WRITTEN DOCUMENTATION FROM A LICENSED VETERINARIAN CONTAINING DIAGNOSIS AND PROGNOSIS FOR PUP. ONCE PUP IS TAKEN INTO BUYERS POSSESSION ALL SHOTS AND DE-WORMING'S ARE THE RESPONSIBILITY OF THE BUYER. ANY PUP DEVELOPING AN ILLNESS RELATED TO LACK OF PROPER CARE (SUCH AS SHOTS, VET CHECK, WATER, FOOD, AND ETC) WILL NOT BE REPLACED. ALL OTHERSWILL BE REPLACED WITH A PUP OF THE SAME VALUE FROM THE FIRST POSSIBLE BREEDING. IF PUPS AVAILABLE ARE OF THE GREATER VALUE BREEDER WILL DEDUCT ORIGINAL PURCHASE PRICE FORM THE PURCHASE PRICE OF ANOTHER PUP. IN NO CASEWILL A PUPBE REPLACED WITH ONE OF GREATER VALUE WITHOUT DIFFERENCE BEING PAID BY PURCHASER. REFUNDS WILL NORMALLY NOT BE GIVEN.

HOWEVER, THIS WILL BE DEALT WITH ON A CASEBY CASE BASIS AS CERTAIN CIRCUMSTANCES MAY WARRANT IT. ANY CONDITION, WHICH CAN BE TREATED IS NOT COVERED BY THE GUARANTEE. (IT IS RECOMMENDED PUP BE TAKEN TO THE VET WITHIN 24 HOURS OF RECEIVING IT).

- 4. THE PURCHASER AGREES TO TAKE HIS/HER DOG TO A LICENSED VETERINARIAN OF HIS/HER CHOICE WITHIN 72 HRS FOR A HEALTH CHECK.
- 5. SHOULD THE DOG BE DETERMINED TO BE IN ILL HEALTH, BY THE CAUSE OF WHICH IS CLEARLY ATTRIBUTABLE TO THE SELLER, THE DOG MAY BE RETURNED WITH A WRITTEN DIAGNOSIS FORM YOUR VET AND THE DOG WILL BE EXCHANGED FOR A DOG WITH EQUAL VALUE.
- 6. WE WILL TAKE DEPOSITS FOR PICKS ON EACH BREEDING. PICTURES WILL BE TAKEN AND CHOICES WILL BE MADE IN ORDER OF DEPOSITS RECEIVED. PICKS MUST BE MADE AT 6 TO 7 WEEKS OF AGE. PICTURES WILL BE SENT TO INSURE YOUR DECISION FOR YOUR PICK!!
- 7. IT IS THE BUYERS RESPONSIBILITY TO ENSURE THAT SELLER HAS CONTACT INFORMATION TO BE ABLE TO REACH YOU. IF BUYER SHOULD MOVE, HAVE A PHONE# CHANGE, ETC IT IS BUYER RESPONSIBILITY TO NOTIFY SELLER. SELLER WILL NOT ATTEMPT TO TRACK BUYER DOWN IF INFORMATION HAS CHANGED SINCE DEPOSIT WAS PAID. IF WE ARE UNABLE TO REACH YOU WHEN IT IS TIME FOR PICKS TO BE MADE YOUR PICK WILL BE SOLD AND DEPOSIT WILL BE REFUNDED.

- 8. METHODS OF PAYMENT ARE CASH. MONEY GRAM, WESTERN UNION MONEY TRANSFER, CASH APP, VENMO, PAYPAL OR ZELLE NO PERSONAL CHECKS WILL BE ACCEPTED.
- 9. WE WILL NOT SELL A PUP/DOG TO ANYONE WE FEEL WILL NOT PROVIDE RESPONSIBLE OWNERSHIP OR ADEQUATE CARE. BE PREPARED TO SUPPLY REFERENCES UPON OUR REQUEST. BUYER AGREES THAT THEU HAVE NO INTENTIONS OF USING THE PUP/DOG PURCHASED FOR ILLEGAL ACTIVITIES. IN SUCH CASE THAT WE FIND A PUP/DOG PURCHASED FROM US BEING MISTREATED, NEGLECTED, ABUSED, USED ILLEGALLY, OR IN A PUPPY MILL TYPE OPERATION WE RESERVE THE RIGHT TO REPOSES THE PUP/DOG AND NO REFUND WILL BE GIVEN. FURTHERMORE, BUYERAGREES TO KEEP SELLER UPDATED ON CONDITON OF THE PURCHASED PUP/DOG BY WAY OF EMAIL OF POSTAL MAIL AND TO PROVIDE PICTURES OF THE PUP/DOG AT LEAST ONCE PER YEAR.

IF YOU HAVE QUESTIONS ASK THEM BEFORE SENDING A DEPOSIT, SENDING A DEPOSIT INDICATES YOU UNDERSTAND AND AGREE TO EVERYTHING CONTAINED HEREIN.
